DNR has new tool for invasive species work in NR 40

Extensive public and DNR staff review have resulted in a new comprehensive invasive species rule designed to be reasonable, feasible and effective. Beginning September 1, [NR 40](#) will educate the public on preventive measures to control the spread of invasives.

Potentially, many DNR employees from different programs could be involved with implementation of this rule. Because of this, the department is developing guidance documents, reporting forms and other protocols to assist staff carrying out the department's responsibilities under this rule. These tools will be developed over the next several months and will be available on an NR 40 Intranet site that will be created soon. Until that time, details about NR 40 can be found on the Internet site.

There will be training opportunities for staff over the next year. Watch for summaries of the rule and frequently asked questions on "[NR 40 Wisconsin's Invasive Species Identification, Classification and Control Rule.](#)" There also is a media kit "[Wisconsin's New Invasive Species Rule](#)" on the Internet that has general information about this new rule.

The rule focuses on education and creating public awareness of what species to avoid transporting, planting or using in some way. The rule stresses the importance of not transferring plants, animals or water from one water body to another. NR 40 classifies invasive plants, animals and plant disease-causing organisms into two categories: "prohibited" and "restricted." Prohibited species are those that aren't yet found in the state or are known to exist in only in a few locations. When found, these species should be reported immediately so prompt action can be taken to control them and prevent their spread. Report prohibited species occurrences to the contact people listed above. Although restricted species already are widespread, NR 40 will help minimize their movement and further spread. It also includes preventive measures, primarily to slow the spread of aquatic invasives. The new rule doesn't cover disease organisms of fish or wildlife, but it does complement the fish [Viral Hemorrhagic Septicemia \(VHS\)](#) rules.
