**“Frank & Miller Report”**

Ed Frank reported that our dues of \$10.00 were due to be paid for our membership in the Coalition. The members voted to pay the \$10.00.

Ed reported that the stock market continued to slide in January, but that these results would not affect anything unless the market is down as of 12-31-2009.

Bruce Braun reported that the new Horicon International Visitors Center will be dedicated on May 15<sup>th</sup>.

Linda Meyer earlier pointed out that the membership directory will not be placed on the website due to privacy concerns. Dave Ives led a discussion to see if members wished to change the existing policy, and they voted to keep it as is.

It was also suggested that when sending out emails that the members' names and email addresses be hidden. This can be done in several ways, including using the bbc (blind copy) feature or a hidden distribution list, etc. The members approved a motion requesting that all emails from ARC be sent with names and email addresses hidden.

Dave Ives said that at this time the printing of the membership directory is free, but that it may change – so we should be aware of that when considering budgets. Bruce Braun reported that the Natural Resources Foundation may be able to help with the printing and that he will check on that.

Jim Miller reported that he had forwarded information on our website to other ARC chapters around the state and some retirees who are not ARC members.
