Horicon Marsh 2011-2012 speakers' series begins October 5

As part of its education program, the [Horicon Marsh International Education Center](#) is continuing its popular guest speaker program, running from fall 2011 through spring of 2012. These presentations cover a wide range of natural resource and environmental topics of interest to the public.

Kicking off the 2011-2012 lecture series on Wednesday, October 5, will be fisheries biologist **Ron Bruch**. He'll update the audience on management strategies for sturgeon on the Winnebago system, one of largest lake sturgeon populations and fisheries in North America. The sturgeon management program dates back more than 100 years and is a world model for how to conduct sturgeon management effectively. Learn about one of Wisconsin's most unique fish, the sturgeon, and what we're doing to ensure this fish continues to prosper.

DNR's "Wisconsin Land Legacy Report" is one of the foundations upon which the department and others set priorities for protecting and managing the places that make Wisconsin "Wisconsin." You still can get your own copy of the report until the middle of October.

The report summarizes three years of collaborative study with our partners and the public on the places most critical in meeting conservation and recreation needs in the decades to come," said **Steve Miller**, director of the Bureau of Facilities and Lands and the primary sponsor of the study leading to the report.

"The 'Legacy Report' is the foundation from which the department and many others throughout the state make decisions about which lands and waters are the highest priority to protect. It's the 'greenprint' to ensure that we pass on the wealth of Wisconsin's resources to future generations."

Customer service staff across the state will be coordinating employee orders and setting out signup sheets, with a deadline to order by October 14. Some service centers already have copies of the report, and will order additional copies to fulfill orders, once their supplies run out. You'll need to indicate how many copies you'd like. You also can request copies by calling the DNR Call Center at 1(888)937-7463, which will forward your request to your local service center.

If you're in the central office and would like to place an order, go to the information center on the first floor of GEF 2.

Following distribution to staff, remaining copies of the report will be offered again for free to conservation organizations, teachers, agencies and libraries. Any remaining copies will be available to the general public for the cost of shipping, or they can receive a free copy by visiting a DNR service center. DNR warden named national boating officer of year

Treml is second to earn prestigious honor, which comes back to Green Bay

The National Association of State Boating Law Administrators named DNR marine conservation warden **Ben Treml** of Green Bay as their national Boating Law Enforcement Officer of the Year. Upon receiving this award, Treml brings it back to Green Bay where the first recipient also served more than a decade ago.

Retired marine conservation warden **Roger Hansen** was the first to win this national award in 2000. Treml, an 11-year veteran of the warden force, was mentored by Hansen.

"Just like the Green Bay Packers and the Lombardi Trophy awarded to the team after the Packers' victory at the 2011 Super Bowl, this national award for outstanding warden service to the public and the natural resources has returned to Green Bay," Northeast Region warden supervisor **Byron Goetsch** said of the award presented to Trembl on September 13 at the association's 52nd annual meeting in Milwaukee.

The non-profit organization, which represents authorities in all 50 states and U.S. Territories, initiated the national award in 2000 to honor the work of marine officers. Forty-two officers nationwide this year were nominated for the national award.

Trembl's dedication to clearing the public waters of intoxicated boat operators and developing warden water survival training are two reasons behind his top honor from the National Association of State Boating Law Administrators and Revere Survival Products.

Trembl also was named Northern Region Boating Officer of the Year by the Northern Association of Boating Administrators. The award announced in late June symbolizes the highest level of achievement among boating law enforcement officers in the United States.

Warden Trembl has shown a strong boating safety initiative by increasing working relationships with other agencies that patrol his area (including the U.S. Coast Guard). He also is one of the department's two certified water survival instructors and has been critical in developing and providing water survival training to all of the wardens in the state.

Windows 7/Office 2010 pilot underway; rollout to IT staffs is next

On September 9, a few brave volunteers began to pilot the rollout to the department of Microsoft Windows 7/Office 2010, under the watchful eyes of the project team. All is going well with the pilot, and the team is preparing for the next phase of implementation.

The next phase consists of rolling out the new computer operating system and suite of office software to the programs' information technology coordinators (ITCs) and the regional information management specialists (RIMS).

The schedule as it now stands:

- *Pilot rollout: 9/6/2011 – 9/30/2011*
- *Rollout to Bureau of Technology Services and the RIMS: early October*

When ITCs' devices are running Windows 7/Office 2010, and all software packages and applications have tested successfully, they'll provide the project team with a list of devices in their programs to be scheduled for deployment.

As all of this is happening, the Bureau of Technology Services (BTS) moves closer to an implementation start date for the rest of DNR's computer users. In the meantime, the team is doing prep work to assure that the agency's IT assets inventory/problem/change system management tool "ServiceCenter" is ready and able to use to schedule that deployment.

One of the first steps in implementing Windows 7/Office 2010 statewide is to upgrade to PCs/laptops/tablets, otherwise known as "PTDs," (personal technology devices) that can run the new operating system and office suite. ITCs are busy making PTD purchases to complete that initial step of the project.

And, lest you think that that's all our IT folks are doing at this time, the activity concurrently underway with the purchase process is testing all software packages and

applications that now sit on users' PTDs.

With deployment of Windows 7, DNR will transition from a 32 bit operating system (OS) to a 64 bit OS environment. Because of the variety of software and applications used throughout the department, the project team has been testing them in the new environment and is nearly done with this step. Each ITC will be responsible for selecting the method of deployment for their program.

Next up, choosing a method to install the new environment

The next step will involve BTS testing various rollout methods to install the OS and the Office Suite to PCs, laptops, etc. Many of you are familiar with the term "imaging" or "reimaging" of PTDs. If these are new to you, though, it's merely how BTS goes about placing an operating system and office suite on a PTD.

The new generation of Microsoft installation and monitoring systems makes available multiple options to image/reimage a PTD. During the course of the pilot, to be completed at the end of September, the project team has been testing these methods.

Once comfortable with the various methods, BTS staff will be the first to see their software and applications migrate to Windows 7/Office 2010.

Highlights of the pilot, testing and implementation to the new environment:

- During the migration, DNR will have in place an agency-run helpdesk that will handle all questions that arise. Instructions for accessing the helpdesk will be available in a future "Digest" story.
- The department will deploy the image with new virus protecting software. An agreement that DNR entered into with Microsoft includes "ForeFront EndPoint Protection." This new virus protection will integrate and extend security across the agency.
- The image will include interactive training guides, which you'll find on your computer's desktop in a training folder. These guides will help get you started with the new "ribbon" menus layout.
- On the first day of the migration departmentwide this fall, a frequently asked questions (FAQ) document will be available on the ["IT Works"](#) website for easy access.

The Windows 7/Office 2010 Project completion target date is June 30, 2012. The project team emphasizes that the testing and smooth rollout of the new computing environment wouldn't have been possible without those employees and programs that have participated in the pilot testing effort.

Beginning September 25 “out of office” notices available outside network

Beginning September 25, email senders outside the state network will have access to your “out of office” email messages.

The Bureau of Technology Services will enable the “Out of Office Assistant” to go beyond the state’s computer network. In the past, the message was kept internal to the state computer network.

If you prefer that your message not be available to non-state network users because of privacy concerns, or if you want to change your outgoing message, you’ll need to use Outlook Web Access (OWA), instead of Microsoft Outlook.

Setting your “out of office” message using OWA:

- Go to <https://mail.wisconsin.gov>
- Log in with your accounts\<(username) account
- Select “Options” in the upper right hand corner
- Select “Out of Office Assistant” in the options pane on the left
- Select the “Send Out of Office auto-replies” radial button
- Select or deselect the “Send Out of Office auto-replies to External Senders”
- Type your auto-reply message in the text box for internal and external as needed.
- Click “Save” at the top left of the window

Northeast Region's Doug Rossberg passed away

Doug Rossberg, 63, passed away on September 8. DNR employees and many others came together in Door County on September 14 to celebrate Rossberg's life.

The recipient of a double-lung transplant in the late 1990s, Rossberg is described by his former coworkers as a survivor and a fighter, a lover of the outdoors, and a mentor to many in the DNR. He took pleasure in each and every day, something we all can learn from him.

Rossberg culminated his 28-year career working for DNR upon retiring from state service in 2005. He and his wife **Betsy** moved to Door County in 2003. She continues to work for DNR part time in the water program in Sturgeon Bay.

Rossberg spent most of his time with DNR working in the water program. He'd also worked in the solid and hazardous waste program. A strong proponent of working with externals to accomplish the department's mission, Rossberg coordinated citizen academies in the region, providing opportunities for the public to learn more about DNR, its programs and the issues we work on every day.

Dedication of the Heath Van Handel Memorial Forest scheduled for October 15

On April 8, 2009, while performing fire suppression duties, DNR pilot Heath Van Handel died in an accident in Wood County. On Saturday, October 15, 2011, the department will dedicate the Heath Van Handel Memorial Forest in honor and memory of Van Handel's contributions to the department, and the people and natural resources of Wisconsin.



Pilot Heath Van Handel will be remembered through a state forest named in his honor.

The Natural Resources Board at its meeting on October 22, 2010, recognized Van Handel's life and dedication to duty by naming a parcel of DNR-managed land west of Appleton the "Heath Van Handel Memorial Forest." The forest is located in the town of Greenville, in Outagamie County.

Currently at this site, a kiosk conveys Van Handel's commitment:

"This forestland is dedicated in memory of Heath Van Handel who lost his life in an aircraft accident on April 8, 2009. At the time of the accident Heath was performing the duties of fire Air Attack Pilot helping direct firefighters on the ground in the suppression (of) a wildland fire east of the town of Pittsville in Wood County.

"Heath had dedicated his life and career to the Wisconsin DNR as a conservation pilot and died while serving to protect the people of Wisconsin. Heath loved being outside with nature, looking at it from above, and caring for it. Nature held a special place in Heath's heart and woodlands such as these brought him great peace."

The Institute of Paper Chemistry acquired this 38-acre forest in 1956 for use as a nursery, test area and arboretum. New high-quality hybrids of aspen, cottonwood and larch grew quickly for use as pulp for producing paper. An arboretum of aspen trees from around lake states provides flowers for future breeding stock.

DNR purchased the property in 1989. "Several pulp and paper companies contributed funds to enable the formal transfer of land to the State of Wisconsin. A memorandum of understanding provides for continued access to the breeding stock contained in this forest site," reads the kiosk.

A short presentation and dedication is scheduled for 1 p.m., followed by an opportunity to socialize and explore the property.

The site is located at W6379 County Road JJ west of Appleton. It's .7 of a mile west of the intersection of County Road JJ and North Mayflower Rd. on the south side of the road. There's limited parking available on the site. If weather precludes holding the ceremony outdoors, it will be moved to a multi-bay storage garage on the property.
