## **“Frank & Miller Report”**

Phone in report was core was up 4.1% and variable up 5.6% at the end of March, not data from April was available from ETF or SWIB, but the Dow Jones, NASDAC and Standard and Poors were all up 7 to 12 for the year from January.

It was again suggested that members sign up for EFT web page for updates.

The Association of Annuitants annual meeting is scheduled for May 2011.

Bob Schaefer reported on the legislation transferring \$28 million from the Insurance fund to employers around the state as part of Wisconsin Act 13. This is intended to reduce health care premiums for employers, but violates the long standing 'share the cost share the pain' principle of the group insurance program funding mix.

### **Old Business:**

Chuck Pils reported that contact had been made with the DNR Secretary's Office inviting Secretary Cathy Stepp to attend a future ARC meeting. No response has been received to date.

Jim Miller discussed the member survey and associated follow up actions. It was discussed to start the social time at 11 instead of 11:30 and Dave Croft noted that the host sites were open at 11 if folks wanted to arrive earlier for socializing. No change if anticipate for now.

John Hagman reported that the Association now has an IRS tax ID number and accounts at Summit Credit Union including both savings and checking accounts

Ed Frank noted that the testimony on AB 99 precluding DNR professional from setting deer hunting provisions such as earn a buck were a lot like making sausage – not something pretty or that one who likes the results would want to see.

### **New Business:**

Linda Meyer reported on her efforts for the lunch selection location options. There had been interest expressed in some new locations and some different menu options. The group like some of the suggestions, but voted not to seek a buffet option, because of the long queues and delays between when people start to eat and finish. Some of the new locations that met the criteria of

size, flexibility of number of attendees, parking, menu options, etc., included: Halvorson's near Stoughton on US 51, Pedro's - west near West town, Coliseum Bar, the Vintage Pub on Whitney Way. and Erin's Irish Pub near American Family. Discussion ensued about multiple menu items, which was endorsed, if logistics for money collection and identifying the selection for wait staff are not too difficult. A decision is needed by September before the 'snow birds' head south so the calendar for the subsequent year can be produced.
