Eight people were no shows at the party. They had prepaid, and their money was returned to them by John Glennon. John shredded six checks and phoned the people to let them know, and two people had \$18.00 returned to them since they had initially paid for two people, and only one person attended.

Three people cancelled before the head count was called in to Rex's, and their money was returned also. They were not included in the numbers in this report.

Marilyn Howell paid for the labels and the cookies. Marilyn was previously reimbursed \$21.08 for the labels and was reimbursed \$33.00 after the party for the cookies.

John Glennon paid for all of the other items, a total of \$2182.31, and will deduct that amount from the money collected from the attendees. The money collected less the expenses that John paid for will result in \$172.69 being remitted to the Treasurer.

John Glennon will send the Treasurer \$172.69 for party proceeds and the \$6.00 collected from new members.

John Glennon will remit \$178.69 to Ken Weisner.

From that amount Ken has or will pay out \$54.08 to Marilyn Howell.

The total revenue from the party will be \$118.61
